The amount of ₱681,504.00 is hereby appropriated from the Surplus of the Mabinay Medicare Hospital Income for Calendar Year 2016 for Contract of Services of Six (6) Nurses for the period from June 2017 to December 2017, subject to the provisions of Section 28 of Sangguniang Panlalawigan Resolution No. 824, series of 2016, enacting Ordinance No. 26.




