"Be it enacted by the Sangguniang Panlalawigan that:


Section 1. The sum of ₱6,125,088.86 representing unutilized Calamity Fund for Calendar Year 2010 and 2011 is hereby appropriated as Financial Assistance to Individuals in Crisis Situation (AICS).


Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
