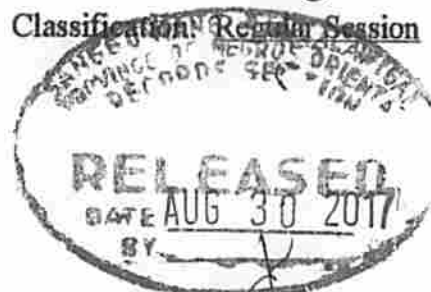

RESOLUTION NO. 738

“Whereas, presented for consideration before the August Body was the letter of the Assistant Provincial Administrator dated July 18, 2017, transmitting Resolution No. 25, current series, of the Local Finance Committee, this province, anent the request of Dr. Clemente S. Hipe IV, Chief of Hospital I, CLLMMH, for augmentation of funds for item ‘Repairs and Maintenance – Buildings and Other Structures’ under the current Regular Budget of the Cong. Lamberto L. Macias Memorial Hospital in the amount of ₱220,500.00, to be taken from the allocation of other MOOE items under the same hospital;

“Funds having been certified as available by the Officer-In-Charge, Provincial Accountant’s Office per certification dated July 6, 2017;

“On motion of Honorable Member Edmund F. Dy, seconded by Honorable Member Nilo D. Sayson, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 17
(Series of 2017)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item ‘Repairs and Maintenance – Buildings and Other Structures’ under the current Regular Budget of the Cong. Lamberto L. Macias Memorial Hospital in the amount of ₱220,500.00, to be taken from the allocation of other MOOE items under the same hospital, viz:

Drugs and Medicines Expenses.....	₱160,500.00
Fuel, Oil and Lubricants Expenses.....	50,000.00
Repairs and Maint. – Transportation Equipment.....	10,000.00

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2017.
