"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of \$\partial 400,000.00\$ representing existing unobligated allotment balance of the allocation for the project Improvement of Waterworks System, Barangay Campuyo, Manjuyod, is hereby reverted to the unappropriated balance of the 20% Development Fund.

Section 2. The amount of P400,000.00 is hereby appropriated from the unappropriated balance of the 20% Development Fund for the Rehabilitation and Improvement of Evacuation Center, Barangay Campuyo, Manjuyod.
