“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of ₱1,250,000.00 is hereby reverted to the unappropriated balance of the 20% Development Fund representing existing unobligated allotment balance of the allocation for the various projects, to wit:

Purchase of Medical Equipment (Nebulizer
and Blood Pressure Apparatus) for
various Cities and Municipalities ₱850,000.00

- 60 pcs. Pediatric Scale




- 70 pcs. Nebulizer



