“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 93  
(Series of 2018)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱18,409,824.42 representing existing Personal Services savings under item Salaries and Wages – Regular Pay including Hospitals is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated to cover the 10-Day Monetization of Leave Credits.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
