“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱50,000.00 representing existing allotment balance of the allocation for the Rehabilitation of Multipurpose Hall, Barangay Alangilan, Sta. Catalina, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Improvement of Waterworks System, Barangay Alangilan, Sta. Catalina.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.





