"RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 12
(Series of 2018)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of ₱5,300,000.00 is hereby appropriated from the Surplus of the General Fund for Calendar Year 2017, for the following:

Logistical Support for Law Enforcement Agencies tasked to provide security during the Buglasan Festival.....	₱ 800,000.00
Additional Appropriation for Buglasan Festival Celebration as subsidy to different local government units participating in the Buglasan Festival 2018.....	4,500,000.00

Section 2. The grant of subsidy to participating local government units is subject to liquidation of previous cash advances from past Buglasan Festivals.
