Concreting of Circumferential Road Including Drainage System at the Bais District Hospital, Bais City.....	980,680.00

Section 2. The amount of ₱1,780,680.00 is hereby appropriated from the unappropriated balance of the 20% Development Fund, for the following:



Construction of Animal Bite Treatment Center (ABTC), Bais District Hospital, Bais City.....₱1,630,680.00
