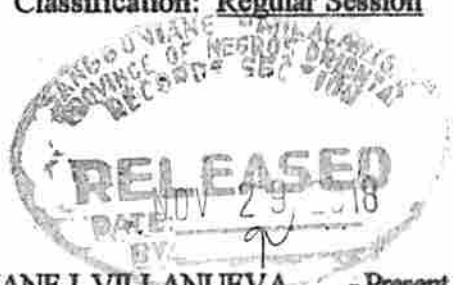

"RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 34
(Series of 2018)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱1,523,412.55 is hereby appropriated from Savings Available from Operations to augment the allocation for item Food Supplies Expenses of the Negros Oriental Detention and Rehabilitation Center, to cover the daily subsistence of 468 inmates for the months of November and December, 2018.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
