“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of ₱600,000.00 representing existing unobligated allotment balance of the allocation for the Construction of Evacuation Center/Multipurpose Building, Barangay II, Bais City, under the 20% Development Fund for Calendar Year 2016 is hereby reverted to the unappropriated balance; the same amount is likewise appropriated for the Concreting of Road from the Evacuation Center down to the end portion after Gilbert Laxina’s Residence, Bais City.


