"Presented for legislative authorization before the August Body was Supplemental Budget No. 31 of the General Fund - 20% Development Fund for Calendar Year 2019 in the amount of ₱3,747,250.00 to cover various infrastructure projects of the provincial government;

"Funds having been certified as available by the Officer-In-Charge, Provincial Accountant's Office;

"On motion of Honorable Member Adem B. Maxino, seconded by Honorable Member Chester V. Lim, the Sangguniang Panlalawigan, in session duly assembled

"RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 47  
(Series of 2019)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱3,747,250.00 TO COVER VARIOUS INFRASTRUCTURE PROJECTS OF THE PROVINCIAL GOVERNMENT.

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱147,250.00 representing unexpended allocation for the Improvement/Rehabilitation of Barangay Kauswagan Water Tank, Kauswagan, Manjuyod, is hereby reverted to the unappropriated balance of

the 20% Development Fund; the same amount is likewise appropriated for the Concreting of Barangay Road, Kauswagan, Manjuyod.

Section 2. The amount of ₱1,000,000.00 representing unexpended allocation for the Construction of Multipurpose Pavement, Barangay Palaslan, Tayasan, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Construction of Multipurpose Building/Evacuation Center, Barangay Palaslan, Tayasan.

Section 3. The amount of ₱1,000,000.00 representing unexpended allocation for the Purchase of Lot (2,102 sq. m.) for the Construction of Multipurpose Hall, Barangay San Francisco, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Concreting of Barangay Road from the Provincial Road Going to Sitio Cantiban, San Francisco, Sta. Catalina.

Section 4. The amount of ₱600,000.00 representing unexpended allocation for the Construction of Spillway in Talisay Beach, Poblacion, Sta. Catalina, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Construction of Drainage Canal at BLISS, Barangay Poblacion, Sta. Catalina.

Section 5. The amount of ₱1,000,000.00 representing unexpended allocation for the Concreting of Road at Purok 6, Barangay Liptong, Valencia, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Concreting of Road at Purok 1 and 2, Barangay Liptong, Valencia.


Section 6. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


