“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 48
(Series of 2019)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱5,654,593.46 TO COVER THE TERMINAL LEAVE BENEFITS DUE TO OFFICIALS AND EMPLOYEES OF THE SANGGUNIANG PANLALAWIGAN.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of ₱5,654,593.46 representing current Personal Services Savings – Salaries and Wages (Regular) is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated to cover the Terminal Leave Benefits of Officials and Employees of the Sangguniang Panlalawigan, namely:



