“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 55
(Series of 2019)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱375,577.75 TO COVER TERMINAL LEAVE BENEFITS OF PROVINCIAL GOVERNMENT EMPLOYEES.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱176,157.51 representing current Personal Services Savings – Salaries and Wages (Regular) is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated for the Terminal Leave Benefits of Mr. Jessie P. Kitane, Security Guard III of the Governor’s Office.

Section 2. The amount of ₱93,466.47 representing current Personal Services Savings – Salaries and Wages (Regular) Including Hospital is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated for the Terminal Leave Benefits of the late Artemio M. Zerna, Utility Worker I of the Provincial General Services Office.




The amount of ₱105,953.77 representing current Personal Services Savings – Salaries and Wages (Regular) is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated for the Terminal Pay of Dr. Ronoel Gene S. Flora, Medical Officer III of the Bindoy District Hospital.

Section 4. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
