"Presented for legislative authorization before the August Body was Supplemental Budget No. 15 of the General Fund for Calendar Year 2019 in the amount of ₱3,000,000.00 as Additional Appropriation for item Buglasan Festival Celebration - Other Maintenance and Operating Expenses (To Include Cash Prizes and Honoraria of Judges);

"Funds having been certified as available by the Officer-In-Charge, Provincial Accountant's Office, and Provincial Treasurer, per certification dated July 8, 2019;

"On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Erwin Michael L. Macias, the Sangguniang Panlalawigan, in session duly assembled

"RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 17
(Series of 2019)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱3,000,000.00 AS ADDITIONAL APPROPRIATION FOR ITEM BUGLASAN FESTIVAL CELEBRATION - OTHER MAINTENANCE AND OPERATING EXPENSES (TO INCLUDE CASH PRIZES AND HONORARIA OF JUDGES) UNDER TOURISM SERVICES PROMOTION OF THE GOVERNOR'S OFFICE.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱3,000,000.00 representing Savings from Operation as of December 31, 2018 is hereby appropriated as Additional Appropriation for item Buglasan Festival Celebration – Other Maintenance and Operating Expenses (To Include Cash Prizes and Honoraria of Judges) under Tourism Services Promotion of the Governor’s Office.

Section 2. A copy of the Financial Statement of Income and Expenses, including a list of sponsors, concessionaires and banners, shall be submitted to the August Body one month after the Buglasan Festival 2019.



Section 3. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.

Section 4. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


