AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱6,138,132.80 TO AUGMENT THE BUDGET OF THE NEGROS ORIENTAL PROVINCIAL HOSPITAL.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱6,138,132.80 representing Savings from Operations of the Negros Oriental Provincial Hospital – Hospital Income is

hereby appropriated to augment the allocation of MOOE items under the budget of same hospital, viz:


Travelling Expenses - Local.....	₱ 695,000.00
Drugs and Medicines.....	2,169,268.80
Other Maintenance and Operating Expenses – Job Order.....	3,273,864.00

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


