AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱7,492,186.00 FOR ITEM OTHER PROFESSIONAL SERVICES UNDER THE BUDGET OF THE NEGROS ORIENTAL PROVINCIAL HOSPITAL.

“Be it enacted by the Sangguniang Panlalawigan that:


Section 1. The amount of ₱7,492,186.00 representing Savings from Operations of the Negros Oriental Provincial Hospital – Hospital Income is hereby appropriated for item Other Professional Services to cover services rendered by personnel hired under Contract of Services in same hospital for the period from September to November, 2019.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
