AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM OTHER MAINTENANCE AND OPERATING EXPENSES UNDER THE BUDGET OF THE PROVINCIAL TREASURER’S OFFICE IN THE AMOUNT OF ₱100,000.00 TO BE TAKEN FROM ITEM PRINTING AND PUBLICATION EXPENSES.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Other Maintenance and Operating Expenses under the budget of the Provincial Treasurer’s Office in the amount of ₱100,000.00 to be taken from item Printing and Publication Expenses, same office, for the purchase of Desk Counter Safety Shield.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2020.


Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
