"Whereas, presented for consideration before the August Body was the letter of the Assistant Provincial Administrator dated November 12, 2020, transmitting Resolution No. 76, current series, of the Local Finance Committee, this province, favorably recommending the augmentation of funds in the amount of ₱96,392.67 for item Terminal Leave Benefits under the current Regular Budget of the Cong. Lamberto L. Macias Memorial Hospital to be taken from the item Salaries and Wages - Regular Pay per letter-request of Dr. Jenellie Faith B. Ozoa, M.D., Chief of Hospital I;

"Whereas, total accumulated leave credits of Ms. Nida Gadingan is only 291.166 per attached Evaluation Worksheet which has a monetary value of ₱216,739.44;

"Whereas, the amount of ₱229,844.32 allocated for the Terminal Leave Benefits of Ms. Gadingan under the current budget is more than sufficient to cover her claim for the same;

"Whereas, funds having been certified as available by the Provincial Accountant per his certification dated November 10, 2020;

"On motion of Honorable Member Kit Marc B. Adanza, seconded by Honorable Member Valente D. Yap, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM TERMINAL LEAVE BENEFITS UNDER THE CURRENT REGULAR BUDGET OF THE CONG. LAMBERTO L. MACIAS MEMORIAL HOSPITAL IN THE AMOUNT OF ₱83,287.79.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Terminal Leave Benefits under the current Regular Budget of the Cong. Lamberto L. Macias Memorial Hospital in the amount of ₱83,287.79 to be taken from the item Salaries and Wages – Regular Pay, to cover the deficiency in the allocation for the Terminal Leave Pay of retired hospital personnel.


