“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 36

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱5,443,130.00 TO FUND VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱100,000.00 representing savings from current Personal Services – Salaries and Wages (Regular) including Hospitals, is

hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated for the Repair and Maintenance of Utility Vehicle, Office of the Provincial Agriculturist.
