"Presented for legislative authorization before the August Body was Supplemental Budget No. 18 of the 20% Development Fund for Calendar Year 2020 in the amount of ₱15,000,000.00 to fund various infrastructure projects of the provincial government;

"Whereas, Resolution No. 62, current series, of the Provincial Development Council, anent the Construction of Multipurpose Building and Facilities at the City Government Center (Phase II) in Barangay Batinguel, Dumaguete City, with an allocation of ₱5,000,000.00 was returned due to the absence of a Program of Work and to a discrepancy in the purpose for which the donation of the project site was executed (school site of the DepEd, Division of Dumaguete City) and the nature of the project which is construction of multipurpose building and facilities;

"Funds having been certified as available by the Provincial Accountant per Certification dated October 7, 2020;

"On motion of Honorable Member Estanislao V. Alviola, seconded by Honorable Member Kit Marc B. Adanza, the Sangguniang Panlalawigan, in session duly assembled

"RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 38
(Series of 2020)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱10,000,000.00 TO FUND VARIOUS INFRASTRUCTURE PROJECTS OF THE PROVINCIAL GOVERNMENT.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱10,000,000.00 representing Current Legislative Appropriation – Purchase of Materials for the Expansion of Waterworks System of Barangays Canaway, Casalaan, Mantiquil, Tayak and Apoloy, Siaton, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated to fund other identified priority projects in the Municipality of Siaton, viz:


Concreting of Road at Barangay Casalaan.....	₱5,000,000.00
Concreting of Road at Barangay Mantiquil.....	5,000,000.00


Section 2. This Appropriation Ordinance shall take effect immediately upon approval.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
