"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of \$\psi\_8,525,000.00\$ representing current Personal Services Savings - Salaries and Wages (Regular) including Hospitals is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated to cover the grant of Productivity Enhancement Incentive to officials and employees at \$\psi\_5,000.00\$ each.

Section 2. This Appropriation Ordinance shall take effect immediately upon approval.
