“Whereas, the Committee recommended for approval the proposed expenditures of the Negros Oriental Provincial Hospital (NOPH) and Provincial Planning and Development Office;

“Funds having been certified as available by the Provincial Accountant and Provincial Treasurer, per certifications dated May 19 and July 13, 2020;

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱19,688,908.57 TO FUND VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱19,618,908.57 representing Savings from Operations under the General Fund for Calendar Year 2019 is hereby appropriated to augment the current budget of the Negros Oriental Provincial Hospital, to wit:

Overtime and Night Pay.....	₱ 1,000,000.00
Office Supplies Expenses.....	2,257,444.11
Drugs and Medicines Expenses.....	14,000,000.00
Medical, Dental and Laboratory Supplies Expenses.....	2,306,964.46
Printing and Publication Expenses.....	20,000.00
Other Supplies and Materials Expenses.....	34,500.00

Section 2. The amount of ₱70,000.00 representing Savings from Operations under the General Fund for Calendar Year 2019 is hereby appropriated for the Purchase of two (2) Units Desktop Computer and two (2) Units Printer for the Provincial Planning and Development Office.

Section 3. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.


Section 4. This Appropriation Ordinance shall take effect immediately upon approval.

Section 5. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
