“Presented for consideration before the August Body was the letter of the Provincial Administrator, this province, dated September 10, 2020, transmitting Resolution No. 54, current series, of the Local Finance Committee, this province, favorably recommending the augmentation of funds for item Maintenance and Operating Expenses – Job Order in the amount of ₱132,000.00 to be taken from item Training Expenses of the allocation for Livelihood Program; Backyard Herbal Medicine; Food Security under Gender and Development;

“Funds having been certified as available by the Provincial Accountant per his certification dated August 20, 2020;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member John T. Raymond, Jr. and Honorable Member Estanislao V. Alviola, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 11
(Series of 2020)

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM OTHER EXPENSES: LABOR (JOB ORDER) IN THE AMOUNT OF ₱132,000.00 TO BE TAKEN FROM ITEM TRAINING EXPENSES OF THE ALLOCATION FOR LIVELIHOOD PROGRAM; BACKYARD HERBAL MEDICINE; FOOD SECURITY UNDER GENDER AND DEVELOPMENT.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Other Expenses: Labor (Job Order) in the amount of ₱132,000.00 of the allocation for Livelihood Program; Backyard Herbal Medicine; Food Security under Gender and Development, to be taken from item Training Expenses of the same program.


Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2020.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
