"RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 14
(Series of 2020)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱2,850,000.00 TO FUND VARIOUS INFRASTRUCTURE PROJECTS OF THE PROVINCIAL GOVERNMENT.

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱550,000.00 allocated for the Construction/Installation of Tents to Serve as Evacuation Center During Calamities in Barangay Poblacion, Sta. Catalina, under the Calendar Year 2015

budget is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Construction of Water System within Barangay Poblacion, Sta. Catalina.

Section 2. The amount of ₱500,000.00 allocated for the Concreting of Road Along Habitat I, Upper UPDD-HOAI Housing Project, Barangay Bajumpandan, Dumaguete City, under the Calendar Year 2015 budget is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Improvement of Road at Habitat I, Bajumpandan, Dumaguete City.

Section 3. The amount of ₱800,000.00 allocated for the Construction of Box Culvert at Sapang Magatas, Sibulan, under the Calendar Year 2016 budget is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Construction of Drainage Canal – Purok 3, Left Portion of the Road, Magatas, Sibulan.

Section 4. The amount of ₱1,000,000.00 allocated for the Construction of Fisherman's Wharf at Looc, Tampocon I, Ayungon, under the Calendar Year 2017 budget is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Concreting of a Portion of Carol-an Barangay Road, Ayungon.

Section 5. This Appropriation Ordinance shall take effect immediately upon approval.

Section 6. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


