“Presented for consideration before the August Body was the letter of the Provincial Administrator dated October 19, 2020, transmitting Resolution No. 93, current series, of the Local Finance Committee, this province, favorably recommending the augmentation of funds for item Terminal Leave Benefits under the current budget of the Negros Oriental Provincial Health Office in the amount of ₱301,602.61 to be taken from item Salaries and Wages – Regular Pay, per letter-request of Dr. Henrissa M. Calumpang, Provincial Health Officer;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Valente D. Yap, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM TERMINAL LEAVE BENEFITS UNDER THE CURRENT BUDGET OF THE NEGROS ORIENTAL PROVINCIAL HEALTH OFFICE IN THE AMOUNT OF ₱301,602.61.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:



Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Terminal Leave Benefits under the current budget of the Negros Oriental Provincial Health Office in the amount of ₱301,602.61 to be taken from the item Salaries and Wages – Regular Pay to cover the Terminal Leave Pay of Ms. Marites A. Tafiac, former Nursing Attendant II of same office.



Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2020.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
