RESOLUTION NO. 263

“WHEREAS, presented for consideration was the letter dated March 16, 2021 of the Provincial Administrator, this province, forwarding Resolution No. 1, current series, of the Local Finance Committee, favorably recommending the amendment of the Calendar Year 2021 Annual Budget of the Provincial Government, relative to One Hundred Fifty-Five (155) Full Time Nurses to be hired under Contract of Services, chargeable against the budget of the Negros Oriental Provincial Hospital;

“WHEREAS, the proposed number of Full Time Nurses under the NOPH Budget was One Hundred Fifteen (115) with an allocation for One Hundred Fifty-Five (155) Full Time Nurses, thus the request for amendment in order to reconcile the same;

“WHEREAS, under the Calendar Year 2021 Annual Budget the approved item of expenditure under the NOPH is ‘Other Professional Services – (15 Full Time Medical Officer III, 1 Executive Assistant III, 1 Administrative Assistant, 115 Full Time Nurse I, 20 Part-Time Nurse I, 5 Social Welfare Officer I, 2 Nutritionist-Dietician I, 7 Pharmacist I, 5 Midwife I, 1 Computer Operator II, 10 Computer Operator I and 5 Physical Therapy Technician I)’ with a total allocation of ₱46,131,840.00;

“WHEREAS, finding the reasons for amendment to be justifiable and considering the urgent need for more nurses at the Negros Oriental Provincial Hospital;

“WHEREFORE, On motion of Honorable Member Erwin Michael L. Macias, seconded by Honorable Member Chester V. Lim, the Sangguniang Panlalawigan, in session duly assembled

“RESOLVES, To enact the following Appropriation Ordinance:

AN ORDINANCE AMENDING SECTION 4 OF RESOLUTION NO. 1153, SERIES OF 2020, ENACTING APPROPRIATION ORDINANCE NO. 41, SPECIFICALLY THE ITEM ‘OTHER PROFESSIONAL SERVICES – (15 FULL TIME MEDICAL OFFICER III, 1 EXECUTIVE ASSISTANT III, 1 ADMINISTRATIVE ASSISTANT, 115 FULL TIME NURSE I, 20 PART-TIME NURSE I, 5 SOCIAL WELFARE OFFICER I, 2 NUTRITIONIST-DIETICIAN I, 7 PHARMACIST I, 5 MIDWIFE I, 1 COMPUTER OPERATOR II, 10 COMPUTER OPERATOR I AND 5 PHYSICAL THERAPY TECHNICIAN I) UNDER THE BUDGET OF THE NEGROS ORIENTAL PROVINCIAL HOSPITAL.

“Be it enacted by the Sangguniang Panlalawigan that:


Section 1. The Item ‘Other Professional Services – (15 Full Time Medical Officer III, 1 Executive Assistant III, 1 Administrative Assistant, 115 Full Time Nurse I, 20 Part-Time Nurse I, 5 Social Welfare Officer I, 2 Nutritionist-Dietician I, 7 Pharmacist I, 5 Midwife I, 1 Computer Operator II, 10 Computer Operator I and 5 Physical Therapy Technician I)’ of the Negros Oriental Provincial Hospital under Section 4 of Resolution No. 1153, series of 2020, enacting Appropriation Ordinance No. 41, is hereby amended to read as follows:


Other Professional Services – (15 Full Time Medical Officer III, 1 Executive Assistant III, 1 Administrative Assistant, 155 Full Time Nurse I, 20 Part-Time Nurse I, 5 Social Welfare Officer I, 2 Nutritionist-Dietician I, 7 Pharmacist I, 5 Midwife I, 1 Computer Operator II, 10 Computer Operator I and 5 Physical Therapy Technician I)

Section 2. This Appropriation Ordinance shall take effect immediately upon approval.


