“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:



Section 1. The Honorable Governor is hereby authorized to augment the allocation for item PhilHealth Contributions under the Regular Budget of the Supervisor’s Office, Community Primary Hospitals, in the amount of ₱3,249.00, to be taken from item Overtime and Night Pay.


Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2021.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.


