“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱10,151.86 is hereby appropriated from the Calendar Year 2020 Savings from Operation of the General Fund, to cover the Reimbursement of Mr. Estanislao A. Silva of the Provincial General Services Office, for personal expenses incurred while processing the Calendar Year 2020 registration of government vehicles owned by the Province of Negros Oriental with Plate Nos. 090808, SDY848, 070108, T60338, SJ3008 and 071607.

Section 2. The amount of ₱830,000.00 is hereby appropriated from the Calendar Year 2020 Savings from Operation of the General Fund, to cover various expenditures of the Provincial Treasurer’s Office, to wit:

Section 3. The amount of ₱450,000.00 is hereby appropriated from the Calendar Year 2020 Savings from Operation of the General Fund, to cover the Purchase of one hundred (100) pieces Oxygen Kit Regulator for the following hospitals:

- Negros Oriental Provincial Hospital (NOPH)
- Bayawan District Hospital
- Cong. Lamberto L. Macias Memorial Hospital
- Gov. William ‘Billy’ Villegas Memorial Hospital

Section 4. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.


Section 5. This Appropriation Ordinance shall take effect immediately upon approval.

Section 6. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


