AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱5,120,000.00 AS ADDITIONAL APPROPRIATION FOR ITEM OVERTIME AND NIGHT PAY OF THE NEGROS ORIENTAL PROVINCIAL HEALTH OFFICE AND FOR THE UNPAID DUES TO THE LEAGUE OF PROVINCES FOR THE YEARS 2011 AND 2013 TO 2019.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱3,000,000.00 is hereby appropriated from the Calendar Year 2020 Savings from Operations of the General Fund, as additional appropriation for item Overtime and Night Pay under the budget of the Negros Oriental Provincial Health Office, to cover overtime services rendered by personnel under the PHO Technical Division during Saturdays, Sundays and Holidays from January 1 to December 31, 2021, to prevent and control local transmission of the COVID-19 Virus in the province.

Section 2. The amount of ₱2,120,000.00 is hereby appropriated from the Calendar Year 2020 Savings from Operations of the General Fund, to cover unpaid dues to the League of Provinces of the Philippines for the years 2011 and 2013 to 2019.



Section 3. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.



Section 4. This Appropriation Ordinance shall take effect immediately upon approval.

Section 5. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


