“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱5,000,000.00 representing unexpended allocation for Various Socio-Economic Development Projects for the

Municipality of Siaton, Negros Oriental, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Concreting of Casalaan Barangay Road, Casalaan, Siaton, Negros Oriental.



Section 2. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.


Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
