“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱500,000.00 representing unexpended allocation for the Improvement of Waterworks System, Claytown Subdivision,

Section 2. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.



Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
