Lamberto L. Macias Memorial Hospital, to be taken from item Other Professional Services, per letter-request of Dr. Jenellie Faith B. Ozoa, M.D., Chief of Hospital I;

"On motion of Honorable Member John T. Raymond, Jr., seconded by Honorable Member Kit Marc B. Adanza, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM MEDICAL, DENTAL AND LABORATORY SUPPLIES EXPENSES UNDER THE CURRENT REGULAR BUDGET OF THE CONG. LAMBERTO L. MACIAS MEMORIAL HOSPITAL, TO BE TAKEN FROM ITEM OTHER PROFESSIONAL SERVICES IN THE AMOUNT OF ₱200,000.00.

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:



Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Medical, Dental and Laboratory Supplies Expenses under the current Regular Budget of the Cong. Lamberto L. Macias Memorial Hospital in the amount of ₱200,000.00 to be taken from item Other Professional Services.



Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2021.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.


