"Presented for consideration before the August Body was the letter of the Assistant Provincial Administrator dated November 3, 2021, transmitting Resolution No. 135, current series, of the Local Finance Committee, this province, favorably recommending the augmentation of funds in the amount of ₱80,000.00 for item Drugs and Medicines Expenses under the current Regular Budget of the Mabinay Medicare Community Hospital to be taken from item Hazard Pay for Contract of Services and Job Order, per letter-request of Dr. Honey Rose E. Duran, M.D., Officer-In-Charge;

"Funds having been certified as available by the Provincial Accountant per his certification dated October 15, 2021;

"On motion of Honorable Member Estanislao V. Alviola, seconded by Honorable Member Erwin Michael L. Macias, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 42
(Series of 2021)

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM DRUGS AND MEDICINES EXPENSES UNDER THE CURRENT REGULAR BUDGET OF THE MABINAY MEDICARE COMMUNITY HOSPITAL IN THE AMOUNT OF ₱80,000.00.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Drugs and Medicines Expenses under the current Regular Budget of the Mabinay Medicare Community Hospital in the amount of ₱80,000.00, to be taken from item Hazard Pay for Contract of Services and Job Order.



Section 3. This Appropriation Ordinance shall take effect immediately upon approval.


