AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM AGRICULTURAL AND MARINE SUPPLIES EXPENSES OF THE NEGROS ORIENTAL ORGANIC AGRICULTURE MANAGEMENT CENTER (GAD) UNDER THE CURRENT BUDGET OF THE PROVINCIAL AGRICULTURIST’S OFFICE IN THE AMOUNT OF ₱250,000.00.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Agricultural and Marine Supplies Expenses of the Negros Oriental Organic Agriculture Management Center (GAD) under the current budget of the Provincial Agriculturist’s Office, in the amount of ₱250,000.00, to be taken from item Prizes.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2021.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
