“Presented for legislative authorization before the August Body was Supplemental Budget No. 36 of the General Fund for Calendar Year 2021 in the amount of ₱13,408,469.57 to cover the grant of COVID-19 Hazard Pay to Regular and Casual Employees including personnel hired under Contract of Services and Job Order for the period from June 16 – 30, 2021;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Kit Marc B. Adanza, the Sangguniang Panlalawigan, in session duly assembled

“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 56
(Series of 2021)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱13,408,469.57 TO COVER THE GRANT OF COVID-19 HAZARD PAY TO REGULAR AND CASUAL EMPLOYEES INCLUDING PERSONNEL HIRED UNDER CONTRACT OF SERVICES AND JOB ORDER FOR THE PERIOD FROM JUNE 16 – 30, 2021.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱13,408,469.57 representing current Personal Services Savings – Salaries and Wages (Regular) including Hospitals is hereby reverted to the unappropriated balance of the General Fund; the same amount is, likewise, appropriated to cover the grant of COVID-19 Hazard Pay to Regular and Casual Employees including personnel hired under Contract of Services and Job Order for the period from June 16 – 30, 2021, to wit:

Section 2. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.



Section 3. This Appropriation Ordinance shall take effect immediately upon approval.


