“Presented for legislative authorization before the August Body was Supplemental Budget No. 38 of the General Fund for Calendar Year 2021 in the amount of ₱1,373,000.00 to cover various expenditures of the provincial government;

“Funds having been certified as available by the Provincial Accountant and Provincial Treasurer;

“On motion of Honorable Member Chester V. Lim, seconded by Honorable Member Valente D. Yap and Honorable Member Jose A. Baldado, the Sangguniang Panlalawigan, in session duly assembled

“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 59
(Series of 2021)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱1,373,000.00 TO COVER VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱1,000,000.00 is hereby appropriated from the Calendar Year 2020 Savings from Operations of the General Fund to cover the cost of Generator Set Fuel Supply to be used by the District Hospitals and Community Primary Hospitals in the province.

Section 2. The sum of ₱373,000.00 representing unexpended allocation for items under Executive Governance - Job Order, Monitoring, Research and Development Activities, to wit:

Fuel, Oil and Lubricants Expenses.....	₱348,000.00
Telephone Expenses.....	25,000.00

is hereby reverted to the unappropriated balance of the General Fund; the amount of ₱373,000.00 is, likewise, appropriated for the Purchase of Thirteen (13) Sets Desktop Computer for Distribution to Selected LGUs, Schools and Barangays in the 1st District.



Section 3. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.



Section 4. This Appropriation Ordinance shall take effect immediately upon approval.


