"RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 60  
(Series of 2021)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱9,290,000.00 TO COVER THE GRANT OF GRATUITY PAY TO CONTRACT OF SERVICES AND JOB ORDER WORKERS OF THE PROVINCIAL GOVERNMENT FOR CALENDAR YEAR 2021.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱9,290,000.00 representing current Personal Services Savings including Hospitals is hereby reverted to the unappropriated balance of the General Fund; the same amount is, likewise, appropriated to cover the grant of Gratuity Pay to Contract of Services and Job Order Workers of the Provincial Government for Calendar Year 2021 per Administrative Order No. 46 of the Office of the President dated December 29, 2021.

Section 2. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.



Section 3. This Appropriation Ordinance shall take effect immediately upon approval.



Section 4. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


