“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱300,000.00 is hereby appropriated from the Calendar Year 2020 Savings from Operations of the General Fund for the Purchase of one (1) unit 4 x 4 Multicab Vehicle for the Girls Scouts of the Philippines, Negros Oriental Chapter.

Section 2. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.


Section 3. This Appropriation Ordinance shall take effect immediately upon approval.


Section 4. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
