“Whereas, presented before the August Body was the letter dated December 26, 2022 of the Officer-In-Charge, Provincial Administrator, this province, forwarding Resolution No. 53, current series, of the Local Finance Committee, favorably recommending the augmentation of funds in the sum of ₱244,095.50 for items Year End Bonus and Cash Gift under the current budget of the Sangguniang Panlalawigan, to be taken from item Mid-Year Bonus per letter-request of Hon. Carlo Jorge Joan L. Reyes, Vice Governor of the Province of Negros Oriental;

“Whereas, funds having been certified as available by the Provincial Accountant per his certification dated November 18, 2022;

“On motion of Honorable Member Kit Marc B. Adanza, seconded by Honorable Member Woodrow S. Maquiling, Sr., Honorable Member Bruno G. Bouffard III and Honorable Member Jessica Jane J. Villanueva, the Sangguniang Panlalawigan

“RESOLVES, To enact, as it hereby enacts, the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 12
(Series of 2022)

AN ORDINANCE AUTHORIZING THE HONORABLE VICE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEMS YEAR-END BONUS AND CASH GIFT UNDER THE CURRENT BUDGET OF THE SANGGUNIANG PANLALAWIGAN IN THE SUM OF ₱244,095.50 TO BE TAKEN FROM ITEM MID-YEAR BONUS.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The Honorable Vice Governor is hereby authorized to augment the allocation for Personal Services items under the current budget of the Sangguniang Panlalawigan in the sum of ₱244,095.50, to be taken from item Mid-Year Bonus, to wit:


Year-End Bonus.....	₱211,595.50
Cash Gift.....	32,500.00

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the item where funds were taken for Calendar Year 2022.


Section 3. This Appropriation Ordinance shall take effect immediately upon approval.




