

RESOLUTION NO. 981

"Presented for legislative authorization before the August Body was Supplemental Budget No. 24 of the General Fund for Calendar Year 2019 in the amount of \$\mathbf{p}\$1,840,520.55 to augment the appropriation for item Food Supplies Expenses of the Negros Oriental Detention and Rehabilitation Center;

"Funds having been certified as available by the Officer-In-Charge, Provincial Accountant's Office per her certification dated September 17, 2019;

"On motion of Honorable Member Valente D. Yap, seconded by Honorable Member Kurt Matthew T. Teves, the Sangguniang Panlalawigan, in session duly assembled

"RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 33 (Series of 2019)

AN ORDINANCE APPROPRIATING THE AMOUNT OF \$1,840,520.55 TO AUGMENT THE APPROPRIATION FOR ITEM FOOD SUPPLIES EXPENSES OF THE NEGROS ORIENTAL DETENTION AND REHABILITATION CENTER.

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of \$1,840,520.55 representing current Personal Services Savings - Salaries and Wages (Regular) is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise

appropriated as additional appropriation for item Food Supplies Expenses of the Negros Oriental Detention and Rehabilitation Center.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
