# APPROPRIATION ORDINANCE NO. 21 (Series of 2022)

AN ORDINANCE APPROPRIATING THE AMOUNT OF \$\mathbf{p}\$54,766,024.00 TO COVER THE GRANT OF GRATUITY PAY TO CONTRACT OF SERVICES AND JOB ORDER WORKERS AND ECONOMIC WELFARE ASSISTANCE TO OFFICIALS AND EMPLOYEES.

DDDODDIATION ODDINANCE NO. 21

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of \$\infty8,560,000.00\$ is hereby reverted to the unappropriated balance of the General Fund representing unexpended balances of the following items of appropriation:

Implementation of Various PPAs in the Devolution Transition Plan and Capability Development Agenda \$\pi\_1,914,512.00\$ Job Order, Monitoring, Records and Development Activities 6,645,488.00

The amount of \$\mathbf{P}8,560,000.00\$ is likewise appropriated to cover the grant of Gratuity Pay to Contract of Services and Job Order Workers, pursuant to Administrative Order No. 03 dated December 23, 2022.

Section 2. The amount of \$\frac{1}{2}\$46,206,024.00 representing current Personal Services Savings including Hospitals is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated to cover the grant of Economic Welfare Assistance to officials and employees occupying regular and casual positions equivalent to one month basic salary, to provide relief on the impact of economic and financial challenges due to inflation.

- Section 3. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.
- Section 4. This Appropriation Ordinance shall take effect immediately upon approval.
- Section 5. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
