"Presented for legislative authorization before the August Body was Supplemental Budget No. 74 of the General Fund for Calendar Year 2018 in the amount of \$\pi\$18,409,824.42 for the Monetization of Leave Credits equivalent to ten (10) days;

"Funds having been certified as available by the Officer-In-Charge, Provincial Accountant's Office, per certification dated November 27, 2018;

"On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Nilo D. Sayson, the Sangguniang Panlalawigan, in session duly assembled

"RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 93 (Series of 2018)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of \$\pi18,409,824.42\$ representing existing Personal Services savings under item Salaries and Wages - Regular Pay including Hospitals is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated to cover the 10-Day Monetization of Leave Credits.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
