Section 1. The amount of \$\phi400,000.00\$ and \$\phi900,000.00\$ representing existing allotment balance of the project 'Rehabilitation and Improvement of Bunsod-Amio Provincial Road, Sta. Catalina, Negros Oriental' and 'Rehabilitation and Improvement of Balayong-Inawasan-Fatima-Calicanan-Amio Provincial Road, Sta. Catalina, Negros Oriental', respectively, are hereby reverted to the unappropriated balance of the 20% Development Fund; the sum of \$\pi1,300,000.00\$ is likewise appropriated for the 'Concreting of Barangay Road at Silfaban Street, Amio, Sta. Catalina'.

The amount of \$\pi700,000.00\$ representing existing allotment balance of the project 'Improvement of Waterworks System at Barangay Upper Buntis, Bacong', is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for Barangay Road Concreting, Buntis-Calangag Road, Bacong.

Section 4. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
