RESOLUTION NO. 295

"On motion of Honorable Member Erwin Michael L. Macias, seconded by Honorable Member Chester V. Lim and Honorable Member Kit Marc B. Adanza, the Sangguniang Panlalawigan, resolves to enact the following Ordinance:

ORDINANCE NO. 15 (Series of 2020)

AN ORDINANCE DECLARING CURFEW FOR ALL PERSONS WITHIN THE TERRITORIAL JURISDICTION OF THE PROVINCE OF NEGROS ORIENTAL.

Be it enacted by the Sangguniang Panlalawigan in session duly assembled:

- SECTION 1. Scope. This Ordinance shall cover all persons within the territorial jurisdiction of the Province of Negros Oriental.
- SECTION 2. Within the duration when the Province of Negros Oriental shall be under General Community Quarantine all persons are prohibited from roaming around, loitering, wandering, staying or meandering in all public places whether singly or in groups starting from 9:00 P.M. to 5:00 A.M.
- SECTION 3. Guidelines. The following guidelines shall be used in the implementation of this ordinance:
 - A. Individuals Exempted from the Curfew. Individuals exempted from the curfew are the following:

- 1. Workers and employees going to and coming from work;
- 2. Individuals purchasing food and other necessities;
- 3. Individuals under medical care and emergencies;
- 4. On-duty health workers, police and military personnel;
- 5. Any government official and employee while in the performance of their duties and responsibilities;
- Those who provide public transport services and delivery services of basic necessities;
- Any person involved in an emergency situation like rescuers, and first responders; and
- 8. All farmers and fisherfolk in the exercise of their livelihood.
- B. For individuals who are still reporting for work, they are required to show their Government or Company-issued ID and Company Certification of <u>DUTY STATUS</u> at designated PNP/LGU/DOH, PCG and AFP checkpoints. Persons who fail to present such documents will not be allowed to pass through the checkpoints/chokepoints.

Along this line, all employees who are not on duty are encouraged to stay at home, and refrain from going out when not necessary.

C. All persons covered under this ordinance shall stay at home during this period from 9:00 P.M. to 5:00 A.M.

SECTION 4. **Enforcement.** All City and Municipal Mayors, and Punong Barangays, PNPO, PCG, BFP, and AFP shall enforce this Ordinance.

SECTION 5. Penalty. Any persons who resist the implementation of this ordinance shall be liable under the Revised Penal Code.

SECTION 6. **Repealing Clause.** All Ordinances, Executive Orders issued by Cities and Municipalities within the Province of Negros Oriental which are inconsistent with any provision/s of this Ordinance are hereby repealed or modified accordingly.

SECTION 7. **Separability Clause.** If for any reason or reasons, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 8. **Effectivity.** This Ordinance shall take effect immediately upon approval.
