"On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Chester V. Lim, the Sangguniang Panlalawigan in session duly assembled

"RESOLVES, To amend Section 27 of Sangguniang Panlalawigan Resolution No. 755, series of 2013, enacting Appropriation Ordinance No. 36, otherwise known as the Annual Budget for Calendar Year 2014 of the provincial government;

"RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 2
(Series of 2014)

Section 1. Section 27 of Sangguniang Panlalawigan Resolution No. 755, series of 2013, enacting Appropriation Ordinance No. 36, is hereby amended to read as follows:


Section 27. Augmentation of Personnel thru Contracts of Services/Memoranda of Agreement. Augmentation of Personnel through Contracts of Services/Memoranda of Agreement in the different offices/divisions should be clearly indicated in their respective budgets and shall be subject to authority from the Sangguniang Panlalawigan. Submission to the Sangguniang Panlalawigan of such request for authority shall be made on or before the month the Contracts of Services/Memoranda of Agreement would commence and shall be on


a six (6) month basis, renewable at the option of the Governor based on need and fund availability and still subject to the authority of the Sangguniang Panlalawigan. Employment is not retroactive.

Section 2. This Appropriation Ordinance shall take effect January 1, 2014.
