“RESOLVES, To approve Addendum No. 2 of the Annual Investment Program for Calendar Year 2014, subject to the usual accounting and auditing rules, regulations and policies;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 3
(Series of 2014)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of ₱3,200,000.00 representing Personal Services savings of the General Fund Proper including devolved hospitals as of March 14, 2014 is hereby appropriated for the grant of Productivity Incentive Bonus to provincial government employees.

Section 2. The amount of ₱250,000.00 is hereby appropriated from the surplus of the General Fund for Calendar Year 2013 as Financial Assistance to Barangay Bonawon, Siaton, for Cultural/Tourism Activities.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
