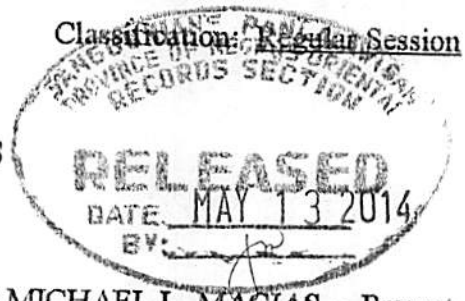

APPROPRIATION ORDINANCE NO. 4  
(Series of 2014)

Section 1. The item Contract of Services (14 Nurses) under Maintenance and Other Operating Expenses of the Negros Oriental Provincial Health Office under Section 2 of Sangguniang Panlalawigan Resolution No. 755, series of 2013, enacting Appropriation Ordinance No. 36 is hereby amended to *Contract of Services (8 Full Time Nurses and 12 Part-Time Nurses)*.

Section 2. The item Contract of Services (3 Nurses) under Maintenance and Other Operating Expenses of the Canlaon District Hospital under Section 4 of Sangguniang Panlalawigan Resolution No. 755, series of 2013, enacting Appropriation Ordinance No. 36 is hereby amended to *Contract of Services (1 Full Time Nurse and 4 Part-Time Nurses)*.


Section 3. The item Contract of Services (2 Medical Technologists and 2 Medical Officer III) under Maintenance and Other Operating Expenses of the Bais District Hospital under Section 4 of Sangguniang Panlalawigan Resolution No. 755, series of 2013, enacting Appropriation Ordinance No. 36 is hereby amended to *Contract of Services (2 Medical Technologists and 2 Part-Time Medical Officer III)*.


Section 4. This Appropriation Ordinance shall take effect January 1, 2014.


