Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Other Supplies Expenses under the current budget of Governor’s Office in the sum of ₱200,000.00 to be taken from other MOOE items of same office, viz:

Training Expenses	₱ 50,000.00
Printing and Binding Expenses	25,000.00
Other Maintenance and Operating Expenses	50,000.00
Office Supplies	75,000.00


