"RESOLVES, To approve Addendum No. 20 of the Annual Investment Program for Calendar Year 2014, subject to the usual accounting and auditing rules, regulations and policies;

"RESOLVES FURTHER, To enact the following Appropriation Ordinance:

(Series of 2014)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱500,000.00 representing existing unobligated allotment balance of the allocation for item Repair and Maintenance - Office Building under the current budget of the Negros Oriental Convention Center is hereby appropriated for the Purchase of two (2) units Automatic Voltage Stabilizer for use at the Negros Oriental Convention Center Elevators, provided that no additional appropriation will be made on the item where funds were derived.




